2. The applicants should be literate, preferable matriculate with a capacity for over all comprehension and should have mind-set to assist the needy in society coupled with the compassion empathy and concern for the upliftment of marginalized and weaker sections of the society.
3. The minimum age for the selection of Para Legal Volunteer should not be less than 21 years as on the date of advertisement.
4. The work of PLVs does not carry any salary, remuneration or wage except remuneration fixed by District Legal Services Authority, Kokrajhar from time to time, as per rules.
5. Application must reach the Office of the District Legal Services Authority, Kokrajhar on or before 07.06.2023 up to 4.30 P.M. from the date of publication of this advertisement. The Authority will not be responsible for any postal delay. No application will be entertained after the last date fixed. The applicants should submit their contact number in their application for further required communication.
6. Application must be accompanied with self attested copies of certificate/diploma etc. in support of their Educational Qualification, age, caste, experience etc along with 3(three) copies of recent passport size photographs duly signed by the candidate on the reverse side.
