**Eligibility criteria:-**

- i. No person shall be selected as Commissioner unless he is a practicing advocate in concerned District.
- ii. No person shall be selected as Commissioner unless he has completed five years practice in the Bar and is a practicing advocate on the day of giving option for employment as Commissioner.
- iii. A willing Advocate shall give declaration that no criminal or civil cases are pending in any court and no disciplinary proceeding is pending in the Bar Council against him.
